## DESCRIPTION OF BUILDING PRODUCT

Mulford supply Futurewood a composite decking system which comprises:

- Futurewood decking, manufactured from 100% recycled HDPE, wood fibre and discarded rice husks or hulls,
- Variety of installation clips manufactured from 316 stainless steel.

The decking planks are offered in different colours with different surface finishes.

It is intended as a decking only, so may not be used as part of a foundation or sub-structure.

Whilst a Futurewood deck is intended for use in areas where the live load does not exceed 2kPa, it may be used in areas subject to greater loads where a substructure is designed to take into account the mechanical characteristics of the boards.

The decking must not be installed to solid substrate such as a concrete slab. In these situations, the **Proframe** project system may be used.

The Futurewood decking system with a coarse sanded finish has been tested to AS 4586:2013. An SRV of 50 was recorded. This means in access routes, only Futurewood planks with a coarse sanded finish may be used. Mulford also recommends that this slip resistant finish should be used wherever the deck is likely to become wet, such as around swimming pools.
