## DESCRIPTION OF BUILDING PRODUCT

Mulford supplies Enviroslat fencing which is part of the Futurewood range.

Futurewood is a composite material manufactured from 100% recycled HDPE (high density polyethylene), wood fibre and discarded rice husks or hulls. The material is resistant to decay, fully finished, and ready for installation. It does not require recoating, although some initial weathering will occur in the first 4 – 12 weeks.

Enviroslat boards are supplied in seven different colours, to a standard 4.8 m length or customised lengths up to 5.8 m.

The boards are intended to be installed to a sub-structure (posts and rails) that have been installed to meet the building code or, where existing, the sub-structure has sufficient structural stability for the fencing installation.
